Dr. Anna-Maria Konsta (LL.B. Aristotle University of Thessaloniki; LL.M. College of Europe, Bruges; Ph.D. European University Institute, Florence) is a tenured Assistant Professor of Comparative Law in the Department of International Studies at the School of Law of the Aristotle University of Thessaloniki, where she teaches Comparative Law and International and European Social Law. She was a visiting professor at the Adam Mickiewicz University, Poznań, Poland, at the Peking University in Beijing, China, a visiting scholar at the China University of Political Science and Law in Beijing, China, and at the University of Alabama, USA. She was, also, a Research Associate in the Department of Politics at the University of Leicester, U.K. an Adjunct Professor at the American College of Thessaloniki, Greece, and a visiting researcher at the School of Law of the University of California at Berkeley, USA. She, also, worked at the Council of Europe in Strasbourg, France and the European Commission in Brussels, Belgium. She is a member of the tripartite scientific committee of the UNESCO Chair on Education for Human Rights, Democracy and Peace at the Aristotle University of Thessaloniki, and the National Coordinator of the Greek Section of the Academic Network on the European Social Charter and Social Rights (RACSE-ANESC). She has published in the field of European and Comparative Social Law with an emphasis on gender equality, nondiscrimination, immigration, citizenship, and social rights.
